# General Terms and Conditions of Participation

1- Messe Stuttgart Ares Fuarçılık Ltd. Şti. that organises the exhibition shall be referred to as the "Organiser", real persons or legal entities attending the exhibition shall be referred to as "Participant", Agreement for Participation shall be referred to as the "Agreement" in hereinafter.

2- This Agreement is accepted, recognised and executed as a deed by and between the parties.

3- Liabilities of the Organiser are as follows:

- Overall cleaning at the exhibition area (stand cleaning to be undertaken by participants),
- Printing out catalogues for the exhibition,
- General decoration of the exhibition area,
- Promotion of the exhibition,
- Taking safety measures for the exhibition area (for the avoidance of doubt, organiser is solely responsible for the safety of exhibition area, the participant shall be responsible for safety and security of goods and products exhibited, as well as insurance and other responsibilities for their personnel employed at the exhibition.)
- Allocation of an exhibition area to each participant in accordance with the attached layout including services written herein,

4 Liabilities of the Participant are as follows:

- Paying attendance fee in full and in advance latest one day before the beginning date of exhibition unless specified otherwise in the Agreement,
- Obtaining Organiser's and venue operators technical management' approval for the decoration project (at Participant's full responsibility),
- Not evacuating or leaving the exhibition area before the ending date of exhibition under any circumstances,
- Being obliged to comply with the laws with regards to personnel it employs, as well as the goods and services to be exhibited; also assuming responsibility for advertisement taxes,
- For the avoidance of doubt, the Participant may neither sublease or transfer or otherwise assign its contractual rights and benefits hereunder to a third party or entity in part or in full.
- The Participant shall assume responsibility for potential damages arising out of or connected to loading/ unloading and transportation of goods.
- Complying with the terms and conditions of technical and administrative specification that will be furnished to it by the Organiser prior to the exhibition.
- Extra stand materials, utilities and services such as phone, water, pressurised air, electricity, stand cleaning, transportation and stand insurance are subject to extra fees. If a Participant wants to use these services and facilities it shall pay for the fees to the Organiser additionally.

5- Accepting to attend the fair or exhibition by signing this Agreement, the Participant may not give up on attendance except for subparagraphs a, b and c below, and it shall be obliged to comply with the contractual liabilities accordingly.

- If the Participant opts out of attending the exhibition at a time more than 6 (six) months prior to the exhibition, it is obliged to pay 25% of the contractual price.
- If the Participant opts out of attending the exhibition at a time of and/or less than 6 (six) months and more than 3 (three) months prior to the exhibition, it is obliged to pay 50% of the contractual price
- If the Participant opts out of attending the exhibition at a time of and/or less than 3 (three) months prior to the exhibition, it is obliged to pay 75% of the contractual price.

The Participant is obliged to serve a written notice of statement for withdrawal. The terms given in subparagraphs a, b, and c above shall be calculated depending on the date such written notice is duly received by the Organiser. In this case, disposal right for the leased area shall rest with the Organiser. In the event that the Participant fails to participate in the exhibition for any reason other than the terms and conditions written herein, the Organiser shall be entitled to the payment of the full participation fee. In this case, the Participant is obliged to fulfil its payment commitments.

The Participant is not authorized to make any discount or deduction in the participation fee.

6- In the event that the Participation Fee is to be paid in instalments, if the Participant fails to pay any instalment on time or in full, the entire remaining Participation Fee shall automatically become due and payable without any further notice. In this case, the Organiser reserves the right of termination due to the breach of the Agreement and the right to claim the damages and all penalty fees in addition to the Participation Fee that is due.

7- The Participant shall be deemed to be in default if it breaches its commitments written in this Agreement in whole or in part or fails to pay the Participation Fee and/or fails to fulfil its obligations on time or in full. The Participant agrees and declares in advance that if it fails to comply with the terms of the payment specified in this Agreement, it shall pay to the Organiser default interest at the rate of 5% per month if the amount to be paid is determined in Turkish Lira and 1% per month if the amount to be paid is determined in EURO.

8- The Parties have agreed that the Organiser has the right to terminate this Agreement due to a breach of the provisions of this Agreement with a unilateral notice in writing in the event of occurring of the following reasons. If the Organiser terminates this Agreement for such reasons, the Organiser shall have the right to demand the total amount of the Agreement / Participation Fee as a penal clause. The Participant irrevocably accepts and undertakes to pay the penal clause amount to the Organiser without the need for any further notice.

- If the Participant breaches its obligation to pay the Participation Fee or the costs of other services requested,
- If the Participant fails to participate in the exhibition for any reason in violation of the terms and conditions written in paragraphs (a), (b) and/or (c) of Article 5, and/or terminates this Agreement in violation of these conditions,
- If the Organiser suffers any damage due to the fault of the Participant or if the Participant causes damage to third parties for any reason under this Agreement.

The claim of the penal clause does not constitute an obstacle to the claim of the performance. The Organiser reserves the right to claim damages in excess of this penal clause.

The Participant cannot be released from its penal clause obligations by paying the penal clause amount once. In the event of termination of this Agreement, the Organiser reserves the right to claim from the Participant both the penal clause agreed in this article and all kinds of damages. The Organiser's failure to exercise this right does not mean that it waives this right. The Organiser has the authority to claim the penal clause amount according to its unilateral decision and/or to setoff it from the payments previously made by the Participant.

9- If and when the exhibition cannot be held at all and/or cannot be held at location designated in the agreement and/or held at the designated location only in part and/or it is postponed for reasons attributable to the owner and/or business manager of the exhibition area, due to resolutions or actions by official bodies or due to force majeure as referred to in relevant and applicable regulations or any other justified reasons; the Organiser shall be at liberty to notify the Participant of the new exhibition area (designating a new stand location and stand ID number per participant) and a new exhibition date (any service to fax or e-mail address of the Participant written in the agreement or a release of announcement on Organiser's web site shall be valid and binding) or alternatively to cancel the exhibition as a whole.

In case the Organiser opts to cancel the exhibition as a whole, fees paid by the Participant, if applicable, shall be returned to the Participant. In any case, the Participant may not and shall not claim for expenses, interest, damages, indemnities under any name whatsoever.

10- If demanded by a Chamber, Association or public bodies and institutions where the Participant is a member, the Organiser shall be entitled to terminate Participant's Agreement and to expel it from the exhibition. In case of any such termination, the Participant may not attend the exhibition in any way and may not claim for expenses, interest, damages, indemnities under any name whatsoever. The Organiser returns any fees collected from the Participant, if any.

11- In case of agreements executed in a foreign currency, selling rate of exchange applicable by the Central Bank on the actual date of payment shall prevail for conversion to TL.

12- The Courts and Execution Offices of Istanbul shall be the competent authorities for all conflicts arising out of or connected to this Agreement.

13- Composed of 13 articles on 2 pages in total, this Agreement covers special terms of participation and the Parties, having acknowledged all articles, executed the Agreement in two copies on ..... / ..... / ..... in their free will.
